l, the undersigned have the honour to report that, on dated 19-05-2023, at around 8:30 AM, a group of miscreants from Meitei community, suspected to be members of Arambai Tenngol, Kangleipak Kanba Lup, Meetei Leepun and other Extremist volunteers numbering more than 500 (Five hundred) people by holding deadly weapons attacked at my Rented Store - "Two Sister Tailoring & Ladies Store" (House Owner name - Mr. Thangminlun Haokip) at New Checkon, Traffic Point, Imphal East.

The miscreants have broke into my store and looted valuable properties, vandalized the store and finally burnt down left behind property and items outside the store. The looted and burnt down properties includes Ladies Tops, TV Sony 55 inch, Kitchen items, Washing Machine, Fridge, Godrej Almirahs, Furniture and Bed, Blankets, Mattress, Syntex, Tailoiring Machines and others property. The total amount of property vandalized, looted and burnt down by the miscreants is estimated to be around Rs. 33,41,000/- (Thirty Three Lakhs and Forty one thousand only).

I could not report the incident to my concern Police Station as well as in time due to the prevailing situation in the state.

Therefore, I request you to lodge an FIR in connection with this incident and booked the miscreants according to the law.
