Other household properties like furniures, utensils and a cash amount of Rs. 69,000/- were also looted.

The approximate value of lost property is calculated at about Rs. 4-5 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
