Sir,

I have the honour to state that, on 04-05-2023 at around 7:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 100-200 persons forcefully entered my rented room at Ponglambi road land No. 5, Porompat, Imphal East, Manipur, and burnt down all the important documents belonging to me and my Sister. Other household properties like furniures, utensils and a cash amount of Rs. 69,000/- were also looted.

The approximate value of lost property is calculated at about Rs. 4-5 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.

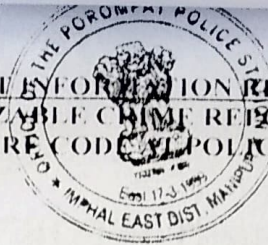
