No. MN06LA 1036 & one two wheelers Vespa, Jewellery, Furnitures, Utensils and grains. etc.

The approximate value of lost property is calculated at about Rs. 3-4 crores

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
