Sir,

I have the honour to state that, on 04-05-2023 at around 5:00 pm my daughter namely, Lhingneithem Olivia Chongloi (21) yrs and her friend namely, Nengpichong Florence Hangshing aged about 24 yrs d/o Paotinthang Hngshing of H. Khopibung who were temporarily working as caretaker at Gama Car wash Near Konung Mamang Oil Pumb, Imphal East, were brutally murdered after being raped and gruesome tortured, by some unknown persons suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 100-200 persons, at their rented house near Konung Mamang. Their dead bodies are not yet recovered and their whereabouts are also not known till date.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
