I have the honour to state that, On 03-05-2023 at around 11:30 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup, Arambai Tenggol, numbering about 900-1000 entered our locality, Haokip Veng, Konung Mamang Palace Compound Imphal East District, Manipur, about 45 Km South, after looting all the moveable properties and cash, they burnt down my house alongwith all the household property including One Auto Rickshaw MN01U 6528, Jewellery, Furnitures, Electronic Gadgets, Clothes, Utensils, Kitchen Wares, Documents, foods and grains etc. leaving us homeless. The approximate value of the lost property is calculated at about Rs. 3,50,00,000/- (Three crore fifty Lakhs).

It is, therefore, requested to kindly registered a regular case and take necessary legal action against the culprits according to law.
