I have the honour to state that, On 03-05-2023 at around 11:30 am some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba I Arambai Tenggol, numbering about 900-1000 entered our locality, Haokip Veng, Konung Mama Palace Compound Imphal East District, Manipur, about 45 Km South, after looting all the moveable properties and cash, they burnt down my house alongwith all the household property including Jewellery, Traditional Ornaments, Furnitures, Electronic Gadgets, Clothes, Utensils, Kitchen Ware, Documents, foods and grains etc. leaving us homeless.

The approximate value of the lost property is calculated at about Rs. 3,00,00,000/- (three crores).

It is, therefore, requested to kindly registered a regular case and take necessary legal action against the culprits according to law.
