Sir,

I have the honour to state that, on 04-05-2023 at around 1:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Haokip veng, Palace compound about 45 Km South from Saikul-PS. They looted all the moveable properties and cash and burnt down my rented house including to ashes leaving all the household items like Furnitures, Electronic items, Utensils, Clothes, Books, Important Academic Documents, etc.

The approximate value of lost property is calculated at about Rs. 15 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.

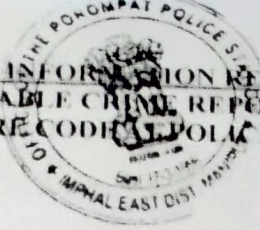
