Sir,

I have the honour to state that, on 04-05-2023 at around 2:15 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered at our locality, Haokip veng, Palace compound, Imphal East Dist. Manipur about 48 Km South from Saikul-PS. After looting all the moveable properties and cash (money) they vandalised my rented house and burnt all my remaining household properties like Furnitures, Jewellery, Electronic items, Utensils, Clothes, Educational Certificates leaving us homeless. The approximate value of lost property is calculated at about 70,00,000/- (Lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
