Sir,

I have the honour to state that, On 04-05-2023 at around 1:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality At Chassad Avenue, New Checkon, Imphal East District, Manipur, about 45 Km South from Saikul-PS. They vandalised my rented house and looted all the moveable properties and cash including, Furnitures, Electronic and Electrical appliances, Kitchen wares, Utensils, Clothes, Books, some important Documents, foods and grains etc.

The approximate value of lost property is calculated at about Rs. 5,00,000 - (five lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.


