Sir,

I have the honour to state that, on 04-05-2023 at around 11:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 500 persons carrying deadly weapons forcefully entered our rented house at New Checkon, Mandop Leirak, Imphal East District, Manipur about 42 Km South from Saikul-PS. They looted all the moveable properties and cash including one Activa 6G bearing regd. No. MN06 SD 6300 alongwith all the Furnitures, Electric and Electronic appliances, Utensils, Clothes, UPSC and SSC CGL study materials etc. The approximate value of lost property is calculated at about Rs. 10 lakhs.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
