I have the honour to state that, on 31-05-2023 at around 09:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 100 persons carrying Sophisticated weapons entered our locality at my rented quarter at Chongthu Baptist Association Church Building, New Checkon Imphal East District, Manipur about 42 km South from Saikul PS.

It is learnt that, after vandaling and looting all the moveable household properties including one Discover Bike bearing Regd. No. MN01Y 7951, Furnitures, Jewellry, Ornaments, Utensils, Electric and Electronic Appliances, Kitchen wares, Utensils, Clothes, Books, all academics documents of my childrens and other important documents, rice and grains etc. The approximate value of lost properties is calculated at about Rs. 30,00,000/- (Thirty lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
