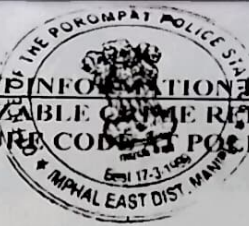

I have the honour to state that, on 05-05-2023 at around 1:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying Sophisticated weapons entered our locality at my rented quarter at Haokip veng, Palace Compound, Imphal East District, Manipur about 45 km South from Saikul PS.

After vandaling and looting all the moveable household properties including, Furnitures, Jewellery, Electric and Electronic Appliances, Kitchen wares, Utensils, Clothes, Office Books of Child Evangelism Fellowship (CEF) Imphal branch, all academics documents and other important documents, rice and grains etc. The approximate value of lost properties is calculated at about Rs. 25,00,000/- (Twenty five lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
