Bed-1, mattress-3, almirah-2, dressing table, drawer, sofa set, refrigerator, dining table, gas box, cabinet, cooler, washing machine, Asus Laptop (Golden colour), Smart TV, Kitchen wares, blanket-25, table fan, TVS N Torq (Red colour) Regn. No. MN06SE1048, Syntaxs-3, table, Gas cylinder-5 & stove, jio fiber, plastic chairs, water dispenser, clothings etc.

Approximate value of total looted Rs. 27,00,000/- (Rupees Twenty seven lakhs)
