Sir,

I have the honour to report that today i.e., 19/06/2023 at @ 6:00 pm, my husband namely Yumkham Premeshor Singh (60) years s/o. (L) Y. Bheigya Singh of Khurai Thangjam Leikai, Imphal East District, Manipur assaulted me near our residential gate located at Khurai Thangjam Leikai without any proper reason. He had also tried to assault my daughter namely Th. Priyalakshmi Devi (25) years. Above that he even took out a **dao** (Khukri/knife) from his Alto car and tried to murder us. However, neighbouring people who were present at the spot somehow manage to save us. As a result, I received injuries on my parts and evacuated at JNIMS hospital for treatment

It is pertinent to mention that he has been illegally living separately with a woman at Sawombung Wairi Mamang Leikai, Imphal East, Manipur for about last 7 (seven) months back.

Therefore, it is requested to kindly take up necessary action against the culprit at the earliest for the end of justice.
