

Today i.e., 20th June, 2023 at @ 11 am, it has come to notice that one unknown miscreant using Facebook account named OM Kangleipak, uploaded the below post (in bold) in a Facebook Page called KANGLA PAO FB ENTERTAINMENT [KPFE].

"Ereichasing. KUKI terrorist thengnaba amukta leppiyu. Laan mai paksi hairadi CM BIREN gi yum Hanna amukta MEI Thadok u.. Magi manao nupa Surrender advisor Boy gi yumdusu. BJP gi MLA minister khudingmak ki yum MEI thao, hatoklo..moigi machasing sirakanda peace lakkani."

Meaning in English:


"Daughters and sons of the land, let us unite together to fight against the Kuki Terrorists. If we are to win the war, we should first set the house of CM Biren on fire and his Brother Boy's house too. Burn all the houses of BJP MLAs and Ministers and kill them all. Peace will prevail only when their children are dead."

As such, the unknown miscreant has deliberately intimidated and threatened to kill and destruction of their houses by setting them on fire. So, there is a very strong apprehension that unwanted incidents are very much likely to take place if such acts are ignored. It is highly suspected that the unknown miscreants in collusions with some like-minded persons are conspiring to commit prejudicial activities.

Therefore, a suo-mottu case under FIR No. 567(6)2023 PRT PS u/s. 115 IPC read with 302/436/506/120-B/34 IPC is registered for investigation.
