





Subject:- Request for lodging of FIR Case regarding looting and burnt down of my house at Moreh Village No. 95, Khunou on 8th May, 2023.

Sir,

I the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Moreh Town on 8th May 2023 at around 4:30 pm. The said unidentified groups burnt down my house and looted all valuable items in that unfortunate incident. I have lost a total amount of Rs. 68 lakhs approximate. My house patta No. are (2305 - .0101 hactare), (159 - .0820 hactare) and (2309 - .0101 hactare) at Village No. 95 Moreh (Khunou). After the said unfortunate incident all the tenant are fleeing and taken shelter at the relief camp.

It is therefore prayed that the respected sir may kindly initiate and take necessary legal actions against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions.
