I hereby inform that on 04-05-2023 at around 10:00 am, during the ethnic problem, some unknown mob broke my gate and entered forcefully into my new house at Haokip Veng, Imphal East Dist. The unknown mob destroyed the properties, took away the valuable properties and finally burnt down all the remaining properties and the house including Activa bearing registration no. MN01AF0622 with Chassis No. ME4JF50CCJT271238. Fortunately our family escaped unhurt for our livelihood. Due to the present prevailing Ethnic problem in the state, the matter could be able to report in time.

The following items were destroyed and burnt as listed below:

1). Wooden Double Bed, 2). Mattres, 3). Bedsheets, 4) Sofa Set, 5). TV 54', 6) Washing Machine, 7). Gas Cylinder - 5 nos., 8). Wooden Almirah - 4, 9) Projector HP, 10). Dress for Men & Women, 11). Bed Box, 12). Utensils, 13). Activa Blue Colour 14). Refrigerator- 2 nos. 15). Rolling Chair, 16). Office Table, 17). Dining Table.

Total approximate value of the property is Rs. 21,50,000 (Rupees Twenty One Lakh, Fifty Thousand only)

So, I therefore, requested you to lodge an FIR into the matter at the earliest.
