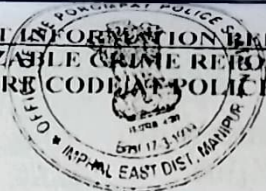




Sir,
