

On 23/6/2023 at @ 8 pm, a large number of unruly mobs numbering about 3000 stormed towards the residential house of Shri L. Sushildro Singh @ Yaima, MLA Khurai AC located at Khurai Sajor Leikai from eastern side of Tinsid Road with intend to burn down the house of the MLA, Khurai AC. So, the security personnel warned them to disperse from the spot at Awang Kongpal Thongkhong along Tinsid Road, Imphal East. Despite of repeated warning, the unruly mobs started pelting stones and even fired several round of tear gas shells towards the security personnel. Having no other option, security personnel had to fire tear gas shells and smoke bombs to control the situation. Later, the situation was stabilized after completely dispersing the unruly mobs at around 12:30 am of 24/06/2023. However, no human casualty was reported.

Hence a suo motto case under FIR No. 578(6)023 PRT-PS u/s 147/148/149/353/188 IPC & 25(1-B)A. Act is registered for investigation.
