Sir,

I have the honour to report that in the midnight between 23 and 24/06/2023 at about 1.00 am some unknown miscreants led by 1. Thabi (Member) 2. Athokpam Borish S/o. A. Bikramjit, and 3. Athokpam Bhopen S/o. A. Tombabu all residence of Top Nongmai Lambi Lampak and his associates forcefully trespassed at our rented house own by Shri L. Sushildro Singh @ Yaima, MLA Khurai AC Located at Yaralpat, Imphal East, Manipur by holding sophisticated weapons and assaulted me and my nephew namely Elangbam Bijoy Singh S/o. (L) E. Tombinao. They also vandalized and looted all belongings inside the residence including cash a sum of Rs. 3,70,000/- which was kept inside the Godrej and burnt down some machineries and the house into ashes. Approximate value of lost properties worth Rs. 3 Crores.

It is therefore, requested to kindly take up necessary legal action against the above noted miscreants according to law.
