Thereafter, they torched my H/Activa 6G (Matte black) bearing regn. No. MN06SH-6392 having Chassis No. ME4JF91AHNW358126 and Engine No. JF91EW7357849 at the spot and reduced to ashes. They also confined/detained me at the place till 3:30 am of 05/05/2023. I could not report in time as I was traumatized by the incident and had to undergo treatment at home.

Therefore, it is requested to kindly arrest the unknown miscreants and punish them as per the law of the land and for the end of justice.
