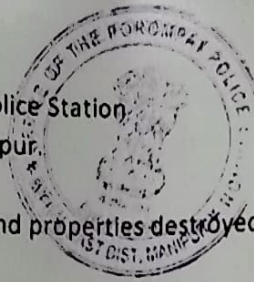

With due respect and humble submission, I, Letkhomang Haokip, 57 Years s/o (L) Tongkhothang Haokip of Haokip veng, Imphal East would like to file a complaint against on properties and House damaged on the 4<sup>th</sup> May, 2023.

My house and properties which is located at Haokip Veng, Imphal East have been vandalized and all properties including important personal file and documents have been looted and destroyed as well as threatening of life, attempted murder by using machete and physically assaulted by the majority Meitei/Meetei community. The approximate value of lost destroyed and looted properties is estimated to be about Rs. 4 Crores.

As the law and order situation is not good in the area. I could not complaint in my respective police station as well in time.

The following items of land and properties were destroyed and looted are as follows :

- 1). Building Value – Rs.3 Crores.
- 2). Households Items and furniture's.
- 3). Two – Wheeler Vehicle's i). (N-torq) Regd.No. : MN 06 SE 8359  
ii). (Honda Activa Regd. No : MN 01 AF 9218)
- 4). Jewellery and Clothing Items.
- 5). Construction Materials.
- 6). Others Movable and Immovable Assets.
