

Subject: Filing of Zero FIR due to my fear of my life and safety because of the riot between kuki and Meetei community regarding thereof.

Dear Sir/Madam,

- 1.) I am writing this letter to inform you that I wish to lodge a Zero FIR in regards to an incident that took place on 3rd of May, 2023 at around 6 p.m at More Bazar ward no.8. A sizable amount of unidentified persons along with deadly weapon in their hands highly suspended from the kuki community committed some barbaric acts towards my property and nearby surrounding area predominantly the properties which are belong to Meetei community situated at More Bazar.
- 2.) It is in fact that my said property was run as a hotel (fast food) named "Abu Kangla Chak Hotel" at More Bazar for earning. Firstly they committed stealing the properties by breaking the front door of my hotel and eventually they burnt down the said hotel and reduced to ashes after stealing the valuable properties for instance some amount of cash, refrigerator, utensils, ceiling fan, furniture, garments etc. which was kept in there. Those miscreants committed the crime in a selective community namely the Meetei community. The property loss/damaged in the incident is estimated about Rs. 60,00,000/- (Sixty lacs) approximately.
- 3.) As the above aforesaid circumstances, it clearly indicates the attraction of section 120B/144/ 148/ 153/ 153A/ 153B/ 380/436/504/451 IPC. Therefore, please accordingly launch zero FIR under the said provisions of IPC as well as any other appropriate law if applicable.
- 4.) Finally, I request you to kindly register a Zero FIR expeditiously for the above-mentioned incident and take necessary action on the case.

Please keep me informed with regular updates about the progress of the case.
