- That my father and I stood firm & confronted them & tried to reason with them but of no avail, for they had predetermined to destroy so came prepared to burn our property, which was evident with the fact that the leader of the group had also brought half litres of petrol bottles that he threw it through the opened front door onto the sofa sets & cushions inside the house. Needless to say, petrol-soaked materials on wooden furniture are tinderboxes, not to mention that the false ceiling, curtains, leather sofas, etc, are ready fuel for fire.
- That even as we tried to calm down the mob, a brick came flying out of nowhere and hit my father's head on the backside. As he fell down, I grabbed him to break his fall, even as blood was oozing out and had to be stopped immediately and so, rushed to the hospital situated on the southern side of our home campus.
- 6. That simultaneously, the leader barged inside my house and lit a lighter and threw it onto the petrol-soaked sofa. The fire spread like wildfire, devouring the dried fabric materials like dried leaves. It quickly spread throughout the entire bungalow house and the duplex behind the main house.
- 7. That they weren't satisfied with the burning of the main house; even as other miscreants began burning the front outhouse, which housed an attached garage where my other Honda Civic sedan was parked inside. This outhouse was also used as store house for exclusive building materials, garden tools, furniture tools and equipment, plumbing materials, false ceiling materials, floor & wall tiles, multiple sanitary items, paint & electrical materials, hardware items, etc. etc. Everything was burnt by them.
- 8. That we somehow managed to escape with our lives with the help of well-wishers from the major Meitei community unlike the radicals, bent on creating disharmony. It was a staged communal ethnic cleansing barbarism act.
- 9. That since I and my family have fled from the state and taken refuge in Delhi, back in Imphal the properties which the family have must be protected by the state authorities. These are: SI. No.-C/R-(P) SL. No.291/303 New Patta No.445/645/806 in the name of Nengzoujam Gangte W/o Lenkhothang Gangte of palace Compound, plot No. of the land under direct possession Sheet No. (26) 5018/5252/(Part) areas 0.10. acre in class Ingkhol, at 38(A) Palace Compound, Unit (B) tehsil Porompat, Sub-Division-Porompat, District Imphal East.
- 10. That all the family members have suffered grievous hurt & and undergoing treatment at different hospitals in Delhi on which medical documents are being attached.

  You are requested to ensure re-partition to our place and restoration of the losses caused to the properties to bring them in pre-riots condition
