Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 5th of May 2023 @ 9:30 am, I was attacked by a group of Meetei/Meitei goons at my rented house situated at New Checkon, Imphal East, P.O/P.S. Porompat, Pin 795005.

These criminal broke open the entrance door of my rented home and all my belonging/household properties was looted, vandalized and burnt down including One Shop owned and run by me by the name of "Wool Store", a total loss estimated to be at an amount of Rs. 90,00,000/- (Ninety Lakhs) Rupees Only by the said meetei/meitei goons.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Cannan Veng, New-Lamka, Churahandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
