Subject: - Report on looting, vandalism and burning of properties.

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 5th of May 2023 @ 9:30 am, I was attacked by a group of Meitei/Meitei goons at my rented house situated at New Checkon, Nongpok Ingkhol, Samaritan Clinic 2nd Floor, P.O./P.S. Porompat, Imphal East District, Pin 795005.

These criminal broke open the entrance door of my rented home and all my belonging/household properties was looted, vandalized and burnt down including one Honda Dio bearing registration no. MN06SF 1351, a total loss estimated to be at an amount of Rs. 8,00,000/- (Eight Lakhss) Rupees Only by the said meitei/meitei goons.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking Thangdong Veng Gangpimual, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
