Subject – **Report against arson of my dwelling house.**

Sir,

I the undersigned, Son of Jamkhongam Touthang (68 yrs old), victim and taking relief/shelter at K. Salbung village, Churachandpur have the honour to state the following for your kind intervention and favourable action that, on 04/05/2023 at around 12:00 AM, unknown mob from Meitei Community armed with deadly sophisticated weapons viz automatic guns like AK-Rifles, SLR, Machete/Sword, iron rods etc. came to our rented house at Chassad Avenue, Imphal East, which compel us to ran for our life. The said mobs looted and vandalized the said rented house with all the household goods inside. The brief description of the properties looted/ stolen/ vandalized are given hereunder:-

The total value of asset is estimated to Rs. 32,55,000 (Rupees Thirty Two Lakhs Fifty Five Thousand) only.
