Subject :-Report against Arson attack of moveable and immovable properties that took place on 3rd May, 2023 between 8:00 - 9:00 PM at our Quarter at KBC Chuch Compound, New Lambulane, within Porompat - PS.

To,

I, the undersigned, father -in-law of Rev Thanglen Haokip, who is a victim and presently taking relief / shelter at Guwahati have the honour to state the following for your kind intervention and favourable action that, on 3rd May 2023, between 8:00-9:00 PM, unknown mobs from the Meitei community armed with deadly sophisticated weapons viz., automatic guns like Ak-rifles, SLR, machete/ sword, iron rods, etc. went to KBC Church which is attached with a Pastor Quarter wherein my son-in-law and his family are currently residing. The said Meitei goons started attacking and burned down the Church and the Pastor Quarter house forcefully along with all the domestic/ household goods remaining inside my said son-in-law's house, to which my son-in-law and his family made a fortunate marginal escape and ran away for their life. Particulars of properties burned:-

- (1) Moveable property (i) Venue Car bearing Redg. No. MN01W 5696 Polar White in colour.
 - (ii) Scooty Wego No. MN02G 3939, Red in colour.
 - (ii) All the valuable domestic/ household goods inside the house;

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 45,00,000/- (Rupees Forty - five lakh) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
