I am to bring to your notice that on the 4th May 2023 between 12pm – 7pm my residence was attacked by a group of people numbering 100 to 200 men suspected to be members called Arambai Tenggol, Meetei Leepun and others.

These criminals broke my gate/s and looted every valuable properties from my house premises worth Rupees 1.51 Crores (Rupees One Crore and Fifty One Lakhs) approximately and burnt down all the remaining things. Fortunately, me and my family managed to escape from these criminals who even tried to kill or burn us alive.

I request you to take strong actions against the perpetrators at the earliest


