

was attacked, destroyed, looted and burned by a Group of Meeitei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property
from my "Owned / Rental" House, and premises worth Rupees. Ninety Seven Lakhs (Approx.)
and they burnt down all the remaining things.

That, my Variety Shop located at C-37 and C-38, Tribal Market, New Lambu
Imphal East was also destroyed and looted.

Therefore, with utmost Respect I request you to take strong actions against the
perpetrators by **registering an FIR** under relevant sections of the Indian Penal Code.
