

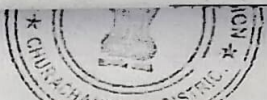

Dear sir,

My name is L. Ngamkholun Haokip s/o (L) Langkholun Haokip a resident of Chassad Avenue, Imphal East District. I currently took refuge in Gangpimuol village, Churachandpur with my family. I am lodging this complaint against unknown miscreants for attempted murder, looting and ransacking of my house, property and valuable documents worth of 25 lakhs (twenty five lakhs).

Particulars of my articles loss, burned or damaged are as given below:

- 1) Sony LED TV 2. Washing machine 3) Sofa set (3 set) 4) Dining table and chair (5nos)
- 5) Four Wooden bed 6) RO 7) Samsung Fridge 8) Mixer Grinder 9. Brass Gong 10) Yamaha R15 (Reg. No. MN01D 3663) 11) Steel Almirah (4) 12) Wooden Almirah and dressing table. 13) Study table. 14. Cash 5 lakhs 15) Gold and ornament 16) Sintex, etc.

The incident took place on Wednesday 3rd May 2023 at 7:00 at Chassad Avenue, Imphal East. These miscreants came to attack my house and my family with arms and weapons. My house was subjected to a horrific act of vandalism where miscreants broke into my property and looted all valuable possessions.

I urge you to take swift action to bring these criminal to justice. These heinous crime have left me and my family in a trauma and unsafe in my own state Manipur.
