

Sir,

I, the undersigned, a victim presently taking relief / shelter at Gouchinkhup Veng, New Lamka have the honour to state the following for your kind intervention and favourable action that, on 4<sup>th</sup> May 2023 at around 06:00-07:00 PM, large number of Meitei goons armed with deadly sophisticated weapons forcefully entered my rented house located at New Checkon, and looted/ robbed all the valuable household goods/ items inside and vandalizing / destroying and burnt down all the remaining items which are not looted. Further, our two-wheeler honda Activa bearing Redg. No. MN01 7818 is missing and could not be found/ traced till date.

That, the total estimated value of all the properties destroyed, looted and robbed is estimated to be worth approximately Rs. 26,00,000/- (Rupees Twenty-six Lakh) only. (Detail particulars of items/ goods destroyed/ looted and burned down are enclosed in separate sheet for easy reference)

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
