

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 6<sup>th</sup> of May 2023 @ 8:30 am I Smt. Hoikhotin Haokip aged about 56 years W/o (L) Seikholam Khongsai was attacked by a group of Meetei/Meitei goons at my rental residential home situated at Golapati, New Checkon, P.S. Porompat, Imphal East.

These criminal on frequent taunting and traumatizing of me and my family, on being scared for my life flee the rental room along with my minor daughter and take refuge at Mantripukhri Assam Rifles Camp, on the aftermath, all my household properties which was left at my rental room at the above mentioned address was looted, vandalized, gutted a total loss estimated to be at an amount of Rs. 10,00,000/- (Rupees One Lakh) by the said meetei/meitei goons.

Fortunately, me and my minor daughter managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Tuibuong, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
