Subject - Report on attempt to murder, thug, assault, battery and harassment.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action

1. That, I am a student, pursuing my nursing studies at Nightingale Nursing Institute situated at Porompat, P.O. & P.S. Porompat, Imphal East District, Manipur, and I am a permanent resident of JS Jangnoi Village, Sokom, Chandel, Manipur-795101.
2. That, at about 04 00 pm on the 04th of May 2023, some radical mobs belonging to meitei/meitei community armed with sophisticated weapons, chanting anti-tribal slogan, barged into my hostel room and dragged me onto the road and, I was harass, abused, tortured and beaten, and was left onto the road believing me to be dead, the perpetrator left me for my fate, but fortunately survived the ordeal and undergone ICU treatment @JNIMS, and in the aftermath shifted @Assam Rifles Clinic, Manipukhri and now currently undergoing treatment at ICU, Churachandpur District Hospital, till date (relevant medical certificates enclosed herewith).
3. That, it may also be reported here that the Meitei (mobs) armed radicals shouted anti tribal slogans while attacking me on the open road and also point their gun at me ready to fire/ shoot at any point

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
