



Subject :- Report against Arson attack of moveable and immovable properties at New Checkon, P.O. & P.S. Porompat, Imphal East District, Manipur.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action:

1. That, at about 1:00 AM on the 4th May, 2023, due to fear of being attacked by furious Meitei mobs, we deserted our house which is situated at New Checkon (Opp. KBC, New Lambulane), P.O. & P.S. Porompat, Imphal East District, Manipur and took refuge at Leimakhong.
2. That, on 4th May 2023 at around 6:000 PM, some unknown mobs from the Meitei community armed with deadly/ sophisticated weapons came and forcefully vandalized and looted our house, thereby causing destruction of our residential house. It may also be reported here that my commercial building lying adjacent to my residential house had also been vandalized.
3. That, the damage caused by the above said attack are as under:
 - (i) Immovable property –Pucca Residential House and semi-pucca commercial building – Rs. 6,70,000/-
 - (ii) Household items - Rs. 5,96,000/-
 - (iii) Electricals & Electronic items - Rs. 1,84,000/-
 - (iv) Kitchen wares & others – Rs. 3,63,800/-
4. That, the total value of both the moveable and immovable properties destroyed, looted and burnt is estimated to be worth approximately Rs. 18,13,800/- (Rupees Eighteen Lakhs Thirteen Thousand Eight Hundred) only.
5. That, it may also be reported here that the Meitei mobs shouted anti tribal slogans while attacking our house.

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
