

**Subject :- Report on looting, Vandalism and burning of properties on 4-5-2023 at 08:00 PM
at Rented house R.K.Lane, New Checkon, Imphal East, P.S.-Porompat**

Sir,

I, the undersigned, Son of (L) Hmingthanglien, who is presently taking relief / shelter at Rengkai have the honour to state the following for your kind intervention and favourable action that, on 4th May 2023 at around 8:00 PM unknown mobs from the Meitei goons or Meitei community armed with deadly sophisticated weapons came and forcefully vandalized, Stolen and looted the property at our Rented Residence in R.K. Lane, New Checkon, Imphal East and the description of which is detailed hereunder :-

(1) Moveable property – All the domestic goods inside the said Rented Residence.

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs.3,22,000/- (Rupees Three Lakhs Twenty Two Thousand) only.

Being me and my family took shelter at Rengkai I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
