

Subject :- Report on looting, Vandalism and burning of properties on 7-5-2023 at 7:00 -8:00 PM at New Checkon, Imphal East, P.S- New Lambulane.

Sir,

I, the undersigned, relative of Mr Haokhothang Touthang S/o Jamkhongam Touthang, who is presently taking relief / shelter at Bangalore, Karnataka, Phone No: 8974102473, have the honour to state the following for your kind intervention and favourable action that, on 7th May 2023 at around 7:00- 8:00 PM unknown mobs from the Meitei goons or Meitei community armed with deadly sophisticated weapons came and forcefully vandalized, Stolen and looted the Rented property at New Checkon, P.S. Porompat Imphal East, and the description of which is detailed hereunder :-

(1) Moveable property – All the domestic goods inside the said Rented Quarter.

That, the estimated value of the moveable property destroyed, looted and burnt is estimated to be worth approximately Rs.35,00,000/- (Rupees Thirty Five Lakhs) only.

Being the occupant of the said rented house is displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
