

Sir,

I have the honour to report that today i.e. the 4th July, 2023, on receipt of a reliable report about presence of some anti-social elements suspected to be members of the outfit United National Liberation Front (UNLF) in and around Andro Parking area with intention to carry out pre-judicial activities like extortion of money from the general public. Acting on the said credible information, I informed to Oscar- 50 (Control room Imphal East) and accordingly a team of Kamjong District Police led by self, assisted by a team of CDO II under the command of Shri K. Herojit Singh, MPS, Addl. SP(Ops) IE and under overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IE conducted search operation in the said area. In that a suspected person was detained for verification at Andro Parking near oil Pump at about 08:30 pm. On spot verification, the detainee identified himself as Ngangom Pamheiba @ Kaki (54) Yrs S/o (L) Ng. Chaoba of Bramapur Nahabam Leikai, IE, an active member of the United National Liberation Front (UNLF) who joined the outfit in the year on 1987 and rose to the rank of S/s Colonel of organization. He further stated that he came to Imphal for his medical treatment. So, he was arrested from the spot i.e. Andro Parking near Oil Pump at 08:40 pm.

It is, therefore, The arrestee is handed over to you for taking up further necessary legal action against him.
