



**Subject :- Report against Arson attack of moveable and immovable properties that took place on 4<sup>th</sup> May, 2023 at about 2:00 pm at Haokip Veng, Near Sanjenthong, P.S. Porompat, Imphal East.**

Sir,

I, the undersigned, a victim and refugee taking relief / shelter at Mahavir Enclave, Delhi at present have the honour to state the following for your kind intervention and favourable action that, on 4<sup>th</sup> May 2023 at around 2:00 pm, unknown mobs from the Meitei community armed with deadly sophisticated weapons viz., automatic guns like Ak-rifles, SLR, machete/ sword, iron rods, etc. came and forcefully vandalized and looted our houses thereby burning our houses and one four wheeler vehicle parked inside our house, the description of which is detailed hereunder :-

- (1) Immovable property – Concrete residential building.
- (2) Moveable property – (i) All the domestic goods inside the house and  
(ii) A Maruti Alto Car bearing registration no. MN01X7773  
(Registered owner- Jamkhongam Haokip) colour: Grey

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 97,86,000/- (Ninety- seven lakh eighty-six thousand) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
