

Subject: Request to register a complaint (Zero-FIR) in c/w recent attack upon me-reg.

Sir,

I am a Central Govt. employee serving as Intelligence Officer, Directorate of Revenue Intelligence, Imphal Regional Unit, Imphal, Manipur.

I would like to inform and register a cognizable offence carried out against me at my rented residence/house located at Paodong Cottage, Chassad Avenue, Nongpok Ingkhol, New-Checkon, Imphal Manipur on the 4th of May, 2023 at around 01:00 PM by a large gathering mob of Meitei Community suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol (valley based Meitei CSO's).

Due to such attack and fearing to lose my life, I along with the other targeted residents of the locality i.e. Kuki Community were evacuated the same day by the Central Paramilitary forces leaving behind all our properties.

On enquiry, all my properties in my rented house were ransacked and looted by the attacking Meitei mob right after we were evacuated.

Therefore, I seek your kind intervention to register an FIR against the culprits and the instigator who abate to carried out such heinous attack against me and my properties for the end of justice.
