IN THE MATTER OF :

An application for taking appropriate action against the above named Accused Persons for the illegal act of kidnapping of Sangomsumpham Sahanaz, aged about 28 years, d/o late Md. Nasir Khan of Kiyamgel Muslim Awang Leikai, Imphal East District, Manipur and wrongfully confining her since 04/10/2023 in their custody by defying her fundamental rights, as well as, to direct the Accusedpersons to produce Sangomsumpham Sahanaz before the Commission so as to hand over her to her natural mother, the present Complainant at an early date.

MOST RESPECTFULLY SHEWETH,

1. That, the present Complainant is a law abiding citizen of India by birth having her residence at Kiyamgei Muslim Awang Leikal within the jurisdiction of Imphal East District, Manipur. The Accused person No. 1 is the main culprit and Accused No. 2 and 3 are his parents and No. 4 is the younger brother of the Accused No. 1, Md. Sakil Ahamad.
2. That, the complainant crave the leave of this Hon'ble Commission for allowing her to file the present application for getting the genuine grievances and reliefs, sought for herein, as the Hon'ble Commission has enough jurisdiction to admit and entertain the present case.
2. That, the present Complainant is the natural mother of Sangomsumpham Sahanaz, aged about 28 years of Kiyamgei Muslim Awang Leikai, Imphal East District, Manipur who has been taking wrongful confinement under the custody of the Accused persons till today since 2:00 p.m. of October 4, 2023 after forcibly kidnapping her by the Accused No. 1, Md. Sakil Ahamad near the bridge of Kiyamgei Awang Leikai and outraging her modesty of a woman.
3. That, when Sangomsumpham Sahanaz was not returned back home since the afternoon of 04/10/2023, the Complainant thinks that she might have been eloped with and waiting to get information but as nobody came to her residence, as such, she went here and there to get any source of information about the missing of her daughter, Sangomsumpham Sahanaz in her locality. Luckily, it has been learnt that her daughter, Sangomsumpham

Sahanaz was forcibly caught and kidnapped by the Accused No. 1, Md. Sakil Ahamad of Hatta Golapati near Auto Parking against her will and left the place immediately.

4. That, on getting the information, a missing report was submitted on 5/10/2023 (Copy) enclosed for ready reference) by Md. Nawaz Khan, elder brother of Sahanaz to the Officer-in-Charge of Irilbung Police Station by mentioning the description of his younger sister and also requested to trace the whereabouts of Sahanaz with a request from her wrongful confinement but no positive action has been initiated so far by the concerned Police Station till today. Being aggrieved by the inaction of Irilbung Police Station, another application had been submitted to the Superintendent of Police, Imphal East at Porompat on 13/10/2023 (Copy enclosed for ready reference) in this regard. However, no positive legal action appears to have been taken by the Office of the Superintendent of Police, Imphal East for tracing in person and safety of the Sangomsumpham Sahanaz, daughter of the present Complainant from the culprits/ Accused persons till today.

In view of the above position and being aggrieved by the inaction of the concerned Police Officers failing to trace out the whereabouts of Sangomsumpham Sahanaz for saving her modesty from the wrongful confinement of the culprits, now fled the present complaint before this commission specially for safeguarding the dignity of her daughter, Sangomsumpham Sahanaz and save to her life from the physical and mental torture of the Accused persons above-named with a desired/ prayer to direct the Accused persons to produce Sangomsumpham Sahanaz before the commission in person, thereafter to hand over her to her natural mother, the present Complainant an early date in the interest of justice.
