Sir,

With due respect, I would like to inform and register a cognizable offence carried out against me on the 4th day of May, 2023 at around 9:15 am by Meitei community, who were armed with sophisticated Pistol, Machette and Knife, whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of Valley based CSO's.

Due to such attack and being in state of vulnerable state. Fearing to lose our life, I along with my family had fled from our resident/home.

As such, we have been taking shelter at my relative house Mr Lalgeorge Neihsel at K. Mongjang Churachandpur District.

On inquiry, Our household were ransacked, torched and burned down to ground. Domestic animals were killed and taken. Similarly, properties were looted and taken away rendering me in a state of homeless person with no place to accommodate me and my families of 5 Male and 5 Female.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my family for the end of justice.
