Due to such attacked carried out against me, being in vulnerable state. We had fled from our village i.e Nongmaipal, P.O- Porompat and P.S. - Lamlai, District-Kangpokpi on account of feating to lose our life.

As such, I have been taking shelter at relief camp allocated to us by Kuki Inpi Churachandpur (KIC).

On inquiry, my house was ransacked and burnt to ground. Properties were looted and taken away.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my families for the end of justice.
