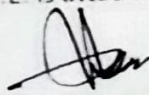
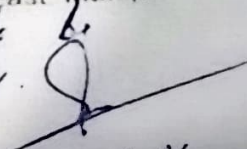

With due respect, I the undersigned would like to introduced myself as Rev J Thanglur presently working as Secretary of Mission Field, ICI Secretariat General Head Quarter, Sielmat and would like to make a report to your good office about vandalism and destruction of Church building of Independent Church of India (ICI) located at Chana Maning Leikai P.O-Lamlong P.S- Lamlai & District- Imphal East on 03-05-2023 at 4:00 PM by Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun.

At the very outset, that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 03-05-2023, on the said day of 03-05-2023 some Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun enter the compound of our Church at around 4:00 pm started to vandalized and destruct all the Church including all the property which was kept inside the church worth Rs. 95,650/- (Rupees Ninety five Thousand and Six Fifty) only.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against the perpetrator as per Law and also issue me the copy of the said report for my reference in future.
