Sir,

I have the honour to state that, on 04-05-2023 at around 03:40 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepu Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Scheduled Tribe Demand Committee (STDC) have brutally murdered my younger brother namely N Thangminlen Vaiphei aged about 32 yrs at Chingarel under Imphal East District, Manipur about 12 Km from Saikul-PS.

My brother is an innocent and law abiding citizen working as a carpenter at Chingarel Carpentry. The whereabouts of his soulless body is also known till date.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
