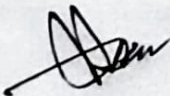
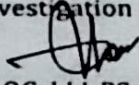

Subject : Report.

Sir,

I have the honour to state that, on 03-05-2023 at around 08:00 pm some unknown miscreant suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanb Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 700-800 persons carrying sophisticated weapons like AR Rifles, SLR, INSAS and .303 Rifles, forcefully entered our village, N. Heikon, Po- Lamlong, PS Lamlai, Island Sub-Division, Kangpokpi District, Manipur having 39 houses about 68 Km East from Saikul-PS. After looting all the moveable properties and cash (money) including Furnitures Electronic items, Utensils, Clothes, Cattle and Domestic animals, food and grains etc. They burnt down all our houses to ground leaving all of us homeless. In addition to, they also burnt down our Church, Community hall. In the incident one Ngampao Lhungdim 50 yrs s/o Sothang Lhungdim was killed by the violent mob.

The approximate value of lost property is calculated at about Rs. 30-40 crores.

It is, therefore, requested to kindly register a regular case without delay and booked the culprits and take necessary legal action against them according to law.
