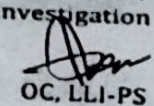

Sir,

I have the honour to state that, on 03/05/2023 9:30 pm some unknown miscreants suspect to be Meitei Youth Organisations, Arambai Tenggol, World Meitei Council (WMC) Meetei Leepun, Kangleipak Kanba Lup (KKL) and Schedule Tribe Demand Committee (STDCC) numbering about 600-700 members carrying sophisticated weapon like AK Rifles, SLR and 30 Rifles forcefully entered in my village, Tera Khong, PO- Yairipok, PS Nongpok Sekmai, Isla Sub-Division Kangpokpi District, Manipur having 39 houses, after looting all the valuat properties like Vehicles, Jewellery, Furnitures, Electronic Items, Utensils, Traditional Ornamen Clothes, Paper Documents, Cattles, Domestic animals, food and grains, has been burnt down ashes leaving us homeless. In addition to, some other important buildings like Church. Church Office were also totally gutted.

The approximate value of lost properties is estimated at about Rs. 35-40 crores.

It is, therefore, requested to kindly registered and regular case and take necessary legal action against the culprits according to law.
