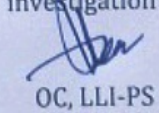

I am Jangkhosat Haokip (70 years) S/o Late Jangkhokhai Haokip Chief of Nongmaipal Village. On 3rd of May 2023 some unknown miscreants in the form of a mob came and burned down 30 houses, the details and the approximate value of which we have provided as below:
