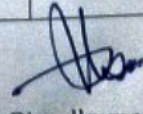

I have the honour to state that, on 04-05-2023 at around 03:40 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) have brutally murder my younger brother namely Mr. Letgunchon Fouthang aged about 18 yrs by using fire arms at Chingarel (steel Almirah Future Store) near Poloi turf ground, Imphal East District, Manipur about 30 Km South from Saikul-PS.

My brother is an innocent civilian and law abiding citizen working at Chingarel (Steel Almirah Future Store). The whereabouts of his soulless body is also not known till date.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
